

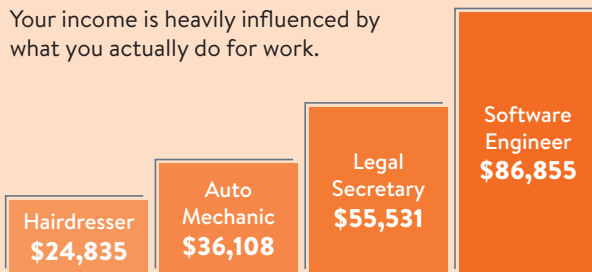

Your income is heavily influenced by what you actually do for work.

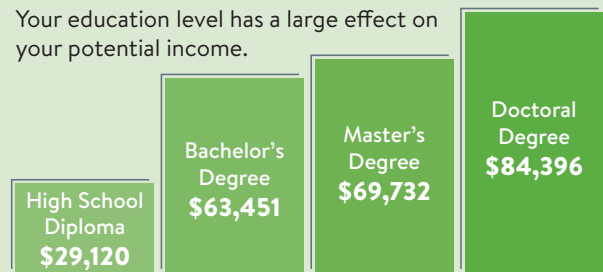


MEDIAN ANNUAL SALARY
